

PUBLIC HEARING NOTICE

Norandal USA, Inc. has applied to the Tennessee Division of Air Pollution Control (TDAPC) for a renewal of their [major source operating permit](#) subject to the provisions of paragraph 1200-3-9-.02(11) of the Tennessee Air Pollution Control Regulations (also frequently referred to as Title V regulations). A major source (Title V) operating permit is required by both the Federal Clean Air Act and the Tennessee Air Pollution Control Regulations. It should be noted that this facility has a current major source (Title V) operating permit. A public hearing will be held to discuss this permit renewal based on Norandal's renewal application dated October 9, 2006, and permit revision applications dated January 27, 2006, June 22, 2007, and May 29, 2008.

The applicant is Norandal USA, Inc. with a site address of 400 Bill Brooks Drive, Huntingdon, TN 38344. They seek to obtain a renewal of their major source operating permit for their aluminum sheet and foil mill. The facility consists of aluminum melting and holding furnaces, annealing ovens, rolling mills, and associated equipment. Pollution control devices include baghouses, afterburners, and an absorption column.

EPA has agreed to treat this draft Part 70 permit modification as a proposed Part 70 permit modification and to perform its 45-day review provided by the law concurrently with the public notice period. If any substantive comments are received, EPA's 45-day review period will cease to be performed concurrently with the public notice period. EPA's 45-day review period will start once the public notice period has been completed and EPA receives notification from the Tennessee Air Pollution Control Division that comments have been received and resolved. Whether EPA's 45-day review period is performed concurrently with the public comment period or after the public comment period has ended, the deadline for citizen's petitions to the EPA Administrator will be determined as if EPA's 45-day review period is performed after the public comment period has ended (*i.e.*, sequentially).
