

## Tennessee Multi-Sector General NPDES Permit (TMSP) Updates

**Update (November 25, 2008)** – The current plan is to issue the TMSP during the first quarter of 2009. The permitting procedure will be: (1) We will send each current permittee a partially completed Notice of Intent (NOI). (2) The permittee will review, update, complete, sign and return the NOI to us. (3) We will issue then issue a five-year Notice of Coverage.

**Updated (September 29, 2008)** - EPA has issued the new Federal Storm Water Multi-Sector General Permit effective today. The single largest change was returning the requirement for total suspended solids (TSS) analysis back to the same sectors as the 2000 permit. The Division of Water Pollution Control will revise and place on public notice the draft permit to reflect the above change, making the TMSP substantially similar to the previous permit. Unchanged proposed benchmark, in mg/L, for other parameters include:

\* These pollutants are dependent on water hardness. The benchmark value listed is based on a hardness of 25 mg/L and a total suspended solids of 31 mg/L.

The TMSP permit should be issued by the end of the year. Then the division will issued partially completed Notice of Intent (NOI) to permittees for reviewing, editing and signing. Upon receipt of the signed NOI, the division will issue new five-year Notices of Coverages.

**Updated (March 16, 2008)** - There are revisions being made to the Federal Multi-Sector General Permit (MSP) and EPA does not expect to issue their permit before next year.

The Tennessee Multi-Sector General Permit (TMSP) expired on December 31, 2006. However, the expired permit remains "in force and effect" until a new permit is

issued. When the new TMSP permit is issued, the division will issue you a new five-year coverage either by e-mail or printed copy.

**Updated (October 3, 2007)** - The Tennessee Multi-Sector General NPDES Permit (TMSP) expired on December 31, 2006. This permit remains in force and effect until the new permit issued. Coverage was administratively extended for facilities that did not request termination of coverage from the last day of the year until the new TMSP permit is issued. Covered facilities should continue to follow the terms of the expired permit.

During the comment period of the draft TMSP, the Tennessee Chamber of Commerce and Industry plus several other commenters asked that the TMSP will not be issued until after the Federal MSP. It is anticipated that the Federal MSP will not be issued before the end of 2007. In that case, the division will issue the new permit sometimes next year.

When the TMSP is issued, those facilities with administrative coverage will automatically be covered and receive a Notice of Coverage either by electronic mail or printed copy.

**Updated (July 26, 2007)** - The Tennessee Multi-Sector General NPDES Permit (TMSP) expired on December 31, 2006. The permit remained in force and effect until the new permit issued. Coverage was administratively extended for facilities that did not request termination of coverage from the last day of the year until the new TMSP permit is issued. Covered facilities should continue to follow the terms of the expired permit.

During the comment period of the draft TMSP, the Tennessee Chamber of Commerce and Industry plus several other commenters asked that the TMSP will not be issued until after the Federal MSP. It is anticipated that the Federal MSP may be issued by September 30, 2007. In that case, the division will issue the new permit by the end of the year.

When the TMSP is issued, those facilities with administrative coverage will automatically be covered and receive a Notice of Coverage either by electronic mail or printed copy. Coverage for new facilities will be issued at that time as well.

There is nothing further for you to do at this time.
